

# TERMS AND CONDITIONS FOR THE FRANK UBER PROMOTION

# Terms & Conditions for the FRANK Uber Promotion ("Promotion") 2016

## **Promotion Period**

The promotion period is from 7 October 2016 to 6 December 2016 (both dates included) or such other period as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC") in its absolute discretion (the "Promotion Period").

# **Eligibility**

- 2. The Promotion is open to all individuals who meet all of the following conditions (collectively "Eligible Cardmembers" and each an "Eligible Cardmember"):
  - a) the relevant individual must have successfully submitted an application for a FRANK Credit Card ("Eligible Card") within the Promotion Period;
  - b) the Eligible Card application submitted under 2(a) above must have been approved by OCBC within the Promotion Period;
  - c) the relevant individual must have activated his/her FRANK Credit Card within the Promotion Period;
  - d) the relevant individual must be below 30 years of age in the year 2016;
  - e) the relevant individual must have not cancelled any FRANK Credit Card within the last 6 months prior to the commencement of the Promotion Period; and
  - f) the Eligible Card must have been applied at Branches / FRANK Stores or through the form linked through the website or promotional communications during the Promotion Period. For avoidance of doubt, applications submitted through other channels will not be eligible for this Promotion.
  - g) the relevant individual must have successfully registered himself/herself with OCBC via SMS and such registration must comply with the requirements as set out in these terms and conditions.

### **Participation**

To register for this Promotion, Eligible Cardmembers must, during the Promotion Period, follow the below steps:

#### Step 1:

Activate your FRANK Credit Card at ocbc.com/activate

# Step 2:

SMS to 76062 in the following format to receive a successful registration SMS reply:

FRANK<space>NRIC or Passport<space> Last 4 digits of card number

Example: FRANK S1111888A 5678

#### Step 3

Each successful and verified registrant will receive a SMS reply on the successful registration made. SMS Reservation is on a "first-come, first-served" and "while stocks last" basis. By way of you sending in your SMS to us under the Promotion, you agree to register for and accept the Terms and Conditions of this Promotion (including those terms and conditions stated herein).

# **The Gift**

- 4. Each Eligible Cardmember is only entitled to redeem a maximum of 2 rides (capped at S\$15 per ride) (the "Gift") under the terms of the Promotion. The eligibility of any cardmember to receive the Gift shall be determined at the absolute discretion of OCBC Bank. Any amount in excess of the cap stated above shall be borne solely by the relevant Eligible Cardmember.
- 5. The process for redeeming the Gift by an Eligible Cardmember is as follows:
  - a) You key in your unique promo code in the Uber app.



- b) You select your FRANK Credit Card as the main Credit Card for payment.
- c) The Gift is only valid on Uber Cars including uberX, uberXL, uberExec and uberExeclarge.
- d) The Gift is valid for use till 8 January 2017. Limited to 1st 900 Eligible Cardmembers.
- The FRANK Credit Card annual fee is \$\$80.00 (including 7% GST). The effective interest rate is 25.92% per annum and is subject to compounding if the monthly charges are not repaid in full. Minimum charge is \$\$2.50 per month and is calculated on a daily basis on the outstanding balance and all new purchases charged to your card account from the date of purchase(s).
