

Terms and Conditions Governing “Like” FRANK by OCBC Facebook Lucky Draw Contest (‘Contest’)

1. The “Like” FRANK by OCBC Facebook Lucky Draw (“Lucky Draw”) is open to all Singapore residents with a valid Singapore mailing address. One lucky draw chance will be given to each participant who ‘like’ FRANK by OCBC Facebook page and completes the lucky draw form. 2. Each participant needs to be a fan of FRANK by OCBC Facebook Page to be eligible to participate in the Lucky Draw.
