

Terms and conditions governing FRANK X MPL SG - In-Store Specials (16 September 2021 to 31 October 2021) ("Campaign")

"You" refers to the customer.

"We/us" refers to OCBC Bank.

Promotion and Eligibility

- The Campaign runs from 16 September 2021 Singapore Time (SGT) 00:00 till 31 October 2021 SGT 23:59 (both dates inclusive), or such other periods(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion ("Campaign Period").
- 2. Participants will receive a FRANK X MPL SG Treasure Case ("Freebie Pack") in any of our FRANK stores if the participants meet following criteria ("Eligible Participant"):
