

## Terms & Conditions Governing the FRANK Card Matching Contest Tampines 1 (the "Contest")

## **Contest Period**

1. The Contest runs from 27 September 2023 till 3 October 2023 (both dates inclusive), or such other periods(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("**OCBC Bank**") at its absolute discretion ("**Contest Period**").

## Eligibility

- 2. You will qualify for the Promotion if you meet one the following conditions ("**Eligible Cardmember**"):
  - a. You are a new FRANK Debit Cardmember who has successfully applied for a FRANK Debit Card (the "**Card**") during the Contest Period. The application must be approved by 10 October 2023.
  - b. You are an existing FRANK Debit Cardmember and your FRANK Debit Card account is active and in good standing with OCBC Bank during the Contest Period.

## **Promotion Mechanics**

- 3. Eligible Cardmember will be given one attempt to play the FRANK Card Matching Game (the "**Play**").
- 4. During the play, the Eligible Cardmember will have to match 8 pairs of cards with identical designs and the time they take to complete the game will be recorded as their timing (the "**Timing**").
- 5. Eligible Cardmember with the fastest Timing for the Play at the end of the Promotion Period (the "**Winner**") will be given one (1) pair of Coldplay Kubik Experience Standing Tickets (SGD 398) on 24 January 2024, Wednesday (the "**Prize**").
- 6. Eligible Cardmember will have to complete and submit the e-Form which the FRANK staff will provide (the "eForm") to record the timing for the Play and facilitate the delivery of the Prize to the Winner only if their timing is faster than the prevailing fastest time.
- 7. Only the Winner will be notified and will be notified within 1 month from the end of the Contest.
- 8. The Prize will be emailed to the Eligible Cardmember's email that was registered in the e-Form or to be self-collected at OCBC Centre.
- 9. Eligible Cardmember will receive the Prize by 30 November 2023.
- 10. The Prize is not transferable or exchangeable for cash, credit, goods and services, products or privileges or other kind in full or in part and is not refundable or replaceable.
- 11. OCBC Bank reserves the right to replace the Prize with another item of similar value without giving any reason or prior notice or assuming any liability to any person.

If any Eligible Cardmember is subsequently discovered to be ineligible to participate in the Promotion or to receive the Prize, OCBC Bank reserves the right to (i) forfeit or withdraw the Prize at any time; or (ii) (where the Prize has been redeemed) claw-back the Prize or request the relevant customer to repay to or compensate OCBC Bank the value of the Prize at any time, and OCBC Bank shall have the right to debit the value of the Prize plus any goods and services tax or such other amount as it deems fit from the account(s) of the customer. No person shall be entitled to any payment or compensation from OCBC Bank should any Prize be forfeited or withdrawn, if any Prize is reclaimed by OCBC Bank, or if a customer is asked to repay to or compensate OCBC Bank the value of the Prize for whatsoever reasons.
